HYDRO-ELECTRIC POWER PROJECTS

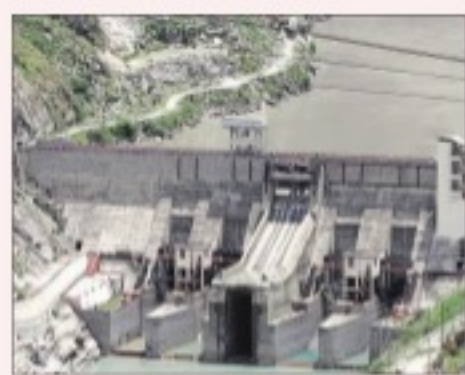
Govt considering ways to lower tariffs

New Delhi, January 22

THE GOVERNMENT IS considering lowering tariffs for new hydro-electric power projects to help them compete against cheaper forms of electricity, according to people with knowledge of the matter.

The power ministry has proposed excluding the costs of building infrastructure such as roads and bridges from tariffs to make new hydro-power projects viable, the people said asking not to be named as the discussions are not public yet. Those costs might be borne by the Centre and the states where the projects are located, the people said, adding that the details haven't been finalised. Power ministry spokesman Rajesh Malhotra declined to comment.

Nearly 100 GW of electricity potential in the country's rivers is lying untapped because of high tariffs. Hydropower projects, often located in remote regions, are crucial to stabilise the



grid as India looks to add 175 GW of renewable capacity. These plants can be swiftly turned on and off, helping the grid withstand fluctuations caused by intermittent supplies from solar and wind. "The cost of building roads and bridges to ferry construction equipment can be quite large, because most of the projects are located in hills," said KM Singh, who in July retired as the chairman of NHPC, India's largest hydro-power producer. "They have a high utility value for states where the projects are located and they should consider bearing these costs."

Besides balancing the electricity grid, hydro-power is also strategically important for In-

dia, as it can boost economic expansion in states that border its neighbors, China and Pakistan. China lays claim to a part of the north eastern state of Arunachal Pradesh, which is among Indian states with the greatest hydro-electricity potential.

The proposals also include making it mandatory for power retailers to include a share of hydro-electricity in their purchases and providing longer-term loans for such projects to even out tariffs over time, the people said. The proposals have been sent to other ministries for consultation. Once finalised, the power ministry will seek approval from the cabinet, the people said.

State electricity retailers, under pressure to shore up their finances so that they can invest in new infrastructure and buy more electricity, have been unwilling to buy high-cost supplies.

The tariff of new hydro projects will work out to about ₹6 a kilowatt hour or more, while most power retailers are looking at a cost of below ₹5 a kilowatt hour, according to Sambitosh Mohapatra, a partner at PwC India. The distribution utilities are unlikely to sign up for such high-priced power because they have cheaper electricity available from thermal and renewable sources, he said.

Wind and solar power tariffs plunged to a record low last year, while the average spot price of electricity in the country was ₹3.37 a kilowatt hour as of Friday noon. India has installed hydropower capacity of about 45 GW, compared with a potential of almost 149 GW, as per the

Central Electricity Authority,
under the power ministry.

TTEs 'forced' to flout rules to increase revenue: Staff union

New Delhi, January 22

A RAILWAY EMPLOYEES' union has alleged that on-board ticket checking staffers were illegally "issued" by officials to legally force tickets to ticket-less passengers for travel in sleeper classes to increase earnings, in violation of rules.

In a letter to the Railway Board on January 21, the All India Railwaymen's Federation said this was a "blatant disobedience" to its orders.

"There are orders from the Railway Board that any passenger found unauthorisedly travelling should be issued ticket up to the next station and then he should be detained at the next station, but all the local CCMs (chief commercial managers of zones) are forcing the TTEs to charge them for farthest end to increase the earnings of the

railways. "This is happening in blatant disobedience to the Railway Board's orders and the TTEs (travelling ticket examiners) are forced to accommodate them in the sleeper class," it said.

The allegations came days after the Railway Board issued a circular on January 19 to all railway zones about complaints of bribes being taken by TTEs from general public for accommodating them in sleeper class.

The letter from the board, which, sources say, has subsequently been withdrawn after the intervention of Railway Board chairman Ashwani Lohani, had instructed the zones to conduct drives by vigilance officials as well as the Railway Protection Force (RPF) to ensure if passengers were travelling illegally in sleeper classes by "paying some illegal gratification to ticket checking staff".
