China weighs tax cut to revive its flagging auto sales

CHINA IS CONSIDERING a tax cut to revive its flagging automotive market, according to people familiar with the matter, lending support to a key industry that's been damaged by an ongoing trade war with the US.

Carmaker shares surged after Bloomberg News reported the potential move, which would stimulate a market they've increasingly relied on for growth. Volkswagen, selling just under 40% of its vehicles in China last year, rose as much as 6.9%, the biggest intraday move since July 2016. Ford Motor and General Motors rallied in pre-market US trading, while BMW and Daimler
