दीपक तलवार की अग्रिम जमानत याचिका खारिज

नई दिल्ली, 26 जुलाई।

वीवीआईपी हेलिकॉप्टर घोटाला मामले में दुबई से भारत प्रत्यापित कॉर्पोरेट लॉबिस्ट दीपक तलवार शुक्रवार को सात दिनों के लिए केंद्रीय जांच ब्यूरो (सीबीआइ) रिमांड पर भेज दिया गया।

इससे पहले एक विमानन घोटाले में गिरफ्तार बिचौलिए दीपक तलवार की अग्रिम जमानत याचिका विशेष न्यायाधीश अनिल कुमार सिसोदिया की ओर से खारिज किए जाने के बाद सीबीआइ ने अदालत कक्ष में ही तलवार को गिरफ्तार कर लिया। फिर जांच एजेंसी ने तलवार से पूछताछ के लिए उसकी 14 दिवसीय हिरासत का अनुरोध किया है लेकिन अदालत ने नहीं माना।

अदालत ने सात दिनों की रिमांड मंजूर की। तलवार इस समय घोटाले से संबंधित धनशोधन के एक मामले में न्यायिक हिरासत में है। उसने केंद्र में कांग्रेस नीत यूपीए की पूर्व सरकार के दौरान कुछ विमानन सौदों में कथित रूप से भ्रष्टाचार निवारण अधिनियम के कारण से
